### **MEDICAID RESOURCE & INCOME LEVELS FOR 2008**

On January 1st of each calendar year, adjustments are made to many of the public benefits numbers in accordance with adjustments in the cost of living index. The following Medicaid numbers reflect the 2008 levels\* (effective January 1, 2008):

Medicaid *Income* Levels:

For a Single Individual	\$725
For a Couple	\$1,067

Medicaid *Resource* Levels:

For a Single Individual	\$4,350
For a Couple	\$6,400

Community Spouse Resource Allowance ("CSRA"):

Minimum: \$74,820      Maximum: \$104,400

Minimum Monthly Maintenance Needs Allowance ("MMMNA"): \$2,610

\* The above figures are taken from General Information System (GIS 07 MA/025) issued by the Office of Medicaid Management. The actual 2008 Medicaid income and resource levels may change slightly once the corresponding Administrative Directive is issued.
