It is an honor and privilege to serve as President of the Dutchess County Bar Association in the coming year. As we begin the year, I am pleased to report that our finances are strong and we are active in both the legal community and in the county at large.

I have four goals that I would like to accomplish during my term as President: increasing our membership roster, maintaining our CLE presentations locally, increasing our Mock Trial competition to all 14 high schools in Dutchess County and establishing a mentoring program for our attorneys recently admitted to practice.

We currently have 465 members in the Dutchess County Bar Association. Our Mock Trial program has grown in the past two years from 4 high schools to 10 that participated in the past year. I am also grateful to the many attorneys who donate their time assisting the teachers who "coach" these teams as they prepare for the competition. With school budgets being slashed everywhere in Dutchess County, it will be a challenge to keep the schools that currently participate to stay involved. I intend to contact each school during the course of the summer to encourage them to sign up next year. Many future attorneys have received their first taste of the law by being a member of this county-wide competition while in high school.

Finally, I am exploring the idea of establishing an informal mentoring program in Dutchess County. We all remember how difficult it was to get started when first admitted to practice. I think it would be helpful to have a network of experienced attorneys who are will-

ing to talk to newly-admitted lawyer from time to time to assist them in all of the "do's and don'ts" of local practice.

We are blessed with an energetic and organized Executive Director, Janna Whearty. Our Executive Committee: Rebecca Valk, Rebecca Blahut, Dan McCabe, Richard Greenblatt and Jonah Triebwasser and Surrogate James D. Pagones are all involved in various activities of our bar association. Our immediate Past President, Maura Barrett, did a phenomenal job leading our organization during the past year and she has pledged to assist me during what will surely be a busy year. I thank her for her service to the bar for the past several years and look forward to working with this talented group of attorneys in the year to come.

Consider joining the DCBA's Lawyer Referral Service

The Dutchess County Bar Association's Lawyer Referral Service is a vital part of our organization. Not only does it assist the public in finding an attorney best suited to assist them with their legal needs, but it offers members the opportunity to receive calls from those specifically seeking an attorney in their practice area. The DCBA provides callers with the names and contact information of up to 3 lawyers that may be able to help them. The DCBA Lawyer Referral Service does not provide pro bono referrals; all attorneys in the service set their own fee structure and have the right to refuse a case.

The service receives an average of 3,120 calls each year (based on a weekly average of 60 calls). The website, where the Referral list is published, also receives 250-300 hits (visits) per month. In total, 6,420 inquiries from potential clients are received each year. There are 43 participants in the service. This means that each participant has the potential to receive approximately 160 referrals each year. The DCBA does not refer to offices that are not participating in the Lawyer Referral Service.

You can join the service at any time. Fees for the year begin at \$140 and are based upon firm size. There are no fees due to the DCBA if you take a case and you can receive referrals from as many practice areas as you choose.

## Proposed new Request for Judicial Intervention (RJI) Form

The Request for Judicial Intervention (RJI) Form set forth in section 202.6 of the Uniform Civil rules for the Supreme and County Courts was last revised in 2000. Since that time, changes in both the law and court system practice have rendered the form outdated. In recent months a team of administrative and court personnel has worked extensively to revise the form and bring it current. Previously, a draft was circulated and a number of proposed revisions were received. Opions are now being saught on the redraft proposal.

## **E-Filing in Supreme Court, Westchester County**

The Office of Court Administration, the Ninth Judicial District Technology Department and the Office of Westchester County Clerk Timothy C. Idoni have been working diligently to implement e-filing in Supreme Court, Westchester County.

They are anticipating the commencement of e-filing, on a voluntary basis, in the Commercial Division, Westchester County, on or about June 21, 2010. That will be followed, over the summer, by the introduction of e-filing, on a voluntary basis, in tort cases in Supreme Court, Westchester County. It is anticipated that, as permitted by legislation, e-filing will become mandatory in tort cases in Supreme Court, Westchester County, in Fall 2010.
